This document defines a Recommended Standard for the CCSDS Streamlined Bundle Security Protocol (SBSP) specification to define security features for the CCSDS Bundle Protocol (BP) (reference [1]) intended for use in delay-tolerant networks in order to provide Delay-Tolerant Networking (DTN) security services.

SBSP provides authentication, integrity, and confidentiality for bundles along a path through a DTN. SBSP is based upon the IETF Bundle Protocol Security Specification (reference [2]) and it is defined streamlined because <include rationale>.

This specification does not address the implementation of security policy and does not provide a security policy for SBSP. Security policies are typically based on the nature and capabilities of individual networks and network operational concepts. However, this specification does recommend policy considerations when building a security policy. This specification does not address how to combine SBSP security blocks with other protocols, other BP extension blocks, or other best practices to achieve security in any particular network implementation.

**To (e.g.):**

This specification does not address

- individual cipher suite implementations as the definition and enumeration of cipher suites should be undertaken in separate specification documents;
- implementation of security policy;
- any security policy for SBSP, but only recommends policy considerations when building a security policy, as security policies are typically based on the nature and capabilities of individual networks and network operational concepts;
- how to combine SBSP security blocks with other protocols, other BP extension blocks, or other best practices to achieve security in any particular network implementation.
