g)	Green Book: The Green Book volume 1 version 3.9 has been submitted to the Area Director and CCSDS Secretariat. While the Secretariat indicated that the two volume approach was possible, the Area Director suggested waiting to publish until the desired changes in volume 2 (i.e., the current Green Book) could be made. Because this could likely take a while based on recent history, there was a suggestion to publish a second Green Book. For the sake of expediency, and better conforming to our original intent, the two volume approach will be followed. During the telecon we selected a title of "Navigation Data Messages Overview" for the new Green Book; based on other document number assignments, it seems likely that it will be numbered CCSDS 500.2-G-1 (the number 500.1-G-1 is taken by the Delta-DOR Green Book).	g)	To David: Submit the title to the AD and Secretariat; inquire whether or not an updated draft is required.
